SYNOPSIS (Include purpose and manner of entry, if appropriate)

Defendant is a native and citizen of Mexico found to be an alien illegally in the United States. Defendant made his latest illegal entry into the U.S. near San Ysidro, CA on or about 9/20/00. Defendant does not have any immigration documents to be or remain in the U.S., nor does defendant have any petitions pending in his behalf. Defendant was located in the Okanogan County Jail, Okanogan, WA on 1/15/01 where he was being held under the charge(s) of Failure To Appear/Pay Fine. On 1/15/01, defendant was found Guilty of these charges and sentenced to ten(10) days in jail. Defendant will be turned over to INS custody on 1/23/01.

Immigration Records show that defendant has been deported from the U.S. on two separate occasions. Defendant was apprehended by U.S. Border Patrol on 1/24/85 in Okanogan, WA and deported on 2/3/95. Defendant was also apprehended on 1/20/97 by U.S. Border Patrol in Chula Vista, CA. Defendant was prosecuted for 8 USC 1326 and was sentenced to 24 months in jail on 3/24/97. Defendant was released from jail on 10/16/98 and was deported from the U.S. on the same date. A review of the defendant's Immigration records shows that he has not applied for, nor been granted, permission from the U.S. Attorney General to reapply for admission into the U.S. after Deportation.

Defendant claims that his true name is [REDACTED], yet Immigration and Criminal records show that he has been apprehended under the name [REDACTED]. Defendant admits that he has used the name [REDACTED], and that he has been deported from the U.S. under this alias.

Defendant's native language is Spanish.


